SPECIAL CALLED MEETING OF THE GREENVILLE TOWN COUNCIL, February 28, 1995.

President Bob Williams called the meeting to order at 12:00 noon with Councilmember Ray Gibson and Jack Sprigler, Clerk Treasurer in attendance.

Also attending was Janet Riggs, Ted Miller, Mike Mudd (Tribune), Bob Gibson, Janice Gibson, Gary Getrost and Geo. Gesenhues, Jr. (Attorney).

Janet Riggs was sworn into office as Councilmember 3rd Ward by the Clerk Treasurer.

Council on motion of Ray Gibson, seconded by Janet Riggs, appointed Ted Miller to the Water Advisory/Rate Board, replacing Janet Riggs. Motion carried 3-0.

Council approved utility claims presented to the Council.


G. Gesenhues stated it was his understanding that this meeting was called for further consideration of an agreement with I-AWW to pay certain claims carried over from the now cancelled water project.

Bob Williams stated the Council is in agreement not to sign any agreement with I-AWW at this time. He stated he believed the Council should continue looking into all alternatives and make sure the Council is not making a mistake by selling the utility or undergoing any expansion. He also stated the Council has been in contact with water suppliers regarding additional water without raising rates. In view of this it is the consensus of the Council not to sign a contract with I-AWW until the current Council has had time to review the entire process before committing the Town to sell the utility or any other agreements.

Council agreed (3-0) to have Mr. Gesenhues contact SEICO to consider their claim against the utility for the cancelled project.


Bob Williams questioned Mr. Gesenhues on current status of other areas he was to undertake and was advised by Mr. Gesenhues that he will report back to the Council at its' next meeting.

No further business coming before the Council the meeting was adjourned on motion of Ray Gibson, seconded by Bob Williams.

A PUBLIC FORUM WILL BE HELD AT A LATER DATE IF THIS COUNCIL FEELS IT IS NECESSARY.


