MINUTES OF GREENVILLE TOWN COUNCIL MEETING, March 10, 1998.

The regular monthly meeting of the Town Council was called to order by President Janet Riggs with Council members Gerald Burkhardt, Ted Miller, Ray Gibson and Mike Receveur and Clerk Treasurer Jack Sprigler attending.

Minutes of the February meeting was approved by the Council (5-0).

Town Attorney Jef Fifer brought the Council up to date on the issues of a Bingo application, annexation and the necessity of a water board. He also apprised the Council of the Ramsey Water Company's situation regarding upgrading their water system. Any decision by Ramsey could result in a financial impact on the Greenville Water system as well as other utilities in the area being served by Ramsey. He stated Greenville need to be any meeting involving the Ramsey Water Company.

Gary Getrost, Utility Superintendent, informed the Council Tyco is devolping property on the Bradford Road and is seeking a water committment from Greenville. He stated the line along the Bradford Road is insufficient for future development, and a larger line is needed. Council suggested the Utility installa 8" line along the road with Tyco paying for a 6" line. Jeff Fifer will send a letter to Tyco explaining the Utility's position for supplying water service.

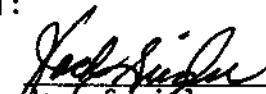
