**MINUTES OF TOWN COUNCIL MEETING
MARCH 14, 2000**

The regular monthly meeting of the Greenville Town Council was called to order by Presiding Officer Ted Miller, with Council members Hanzel Barclay, L. Ray Gibson and Mike Receveur and Clerk Jack Sprigler attending; Council member David Matthews was absent due to work schedule.

Also attending was John Koerber, Rick Morgan(Floyds Knobs Water Co.), Attorney Jef Fifer, Gary Getrost, Janice Gibson and David Moore.

After review by each member, the minutes of the February meeting was approved as written by unanimous vote of the Council.

The Council approved (signed) an agreement with John Koerber for charges computed by Utility Supt. Gary Getrost pertaining to Koerber's development of Stiller Rd.(4-0)

Rick Morgan of Floyds Knobs Water Co. presented the Council a request for increased water rates to \$1.72/M from the current rate of \$1.18/M. Town/Utility attorney Jef Fifer questioned whether the increase is valid since the increase had not been approved by the IURC. Mr. Fifer stated he would check with the IURC Utility Counselor and suggested the Clerk Treasurer check with the State Board of Accounts as of the validity of the increase. Mike Receveur motioned the Town accept the proposed increase after research by Fifer & Sprigler proves to be proper. Motion carried and approved by the Council 4-0.

Jef Fifer introduced Ordinance 2000-01 titled "an Ordinance Concerning Disposal of Trash, Junk and Abandoned Vehicles on Public Property or Public Right-of-Way". Presiding Officer Ted Miller then asked the Council to consider Ordinance 2000-01. On call of the roll all Council members voted "aye" to consider Ordinance 2000-01. Jef Fifer gave the required readings for Council acceptance and approval. On vote of the Council all members voted "aye". Miller then declared Ordinance 2000-01 duly passed by the Greenville Town Council by vote of 4-0.

Attorney Jef Fifer was instructed to research the law regarding the employment status of Utility Operator W.D. Cummins who has been disabled since 8/19/99.

Mr. Fifer was also instructed to pursue the annexation request of Joe Poston.

Gary Getrost, Utility Supt, presented the Council with engineering proposal for the State of Indiana Stiller Road project. Two (2) proposals were submitted:



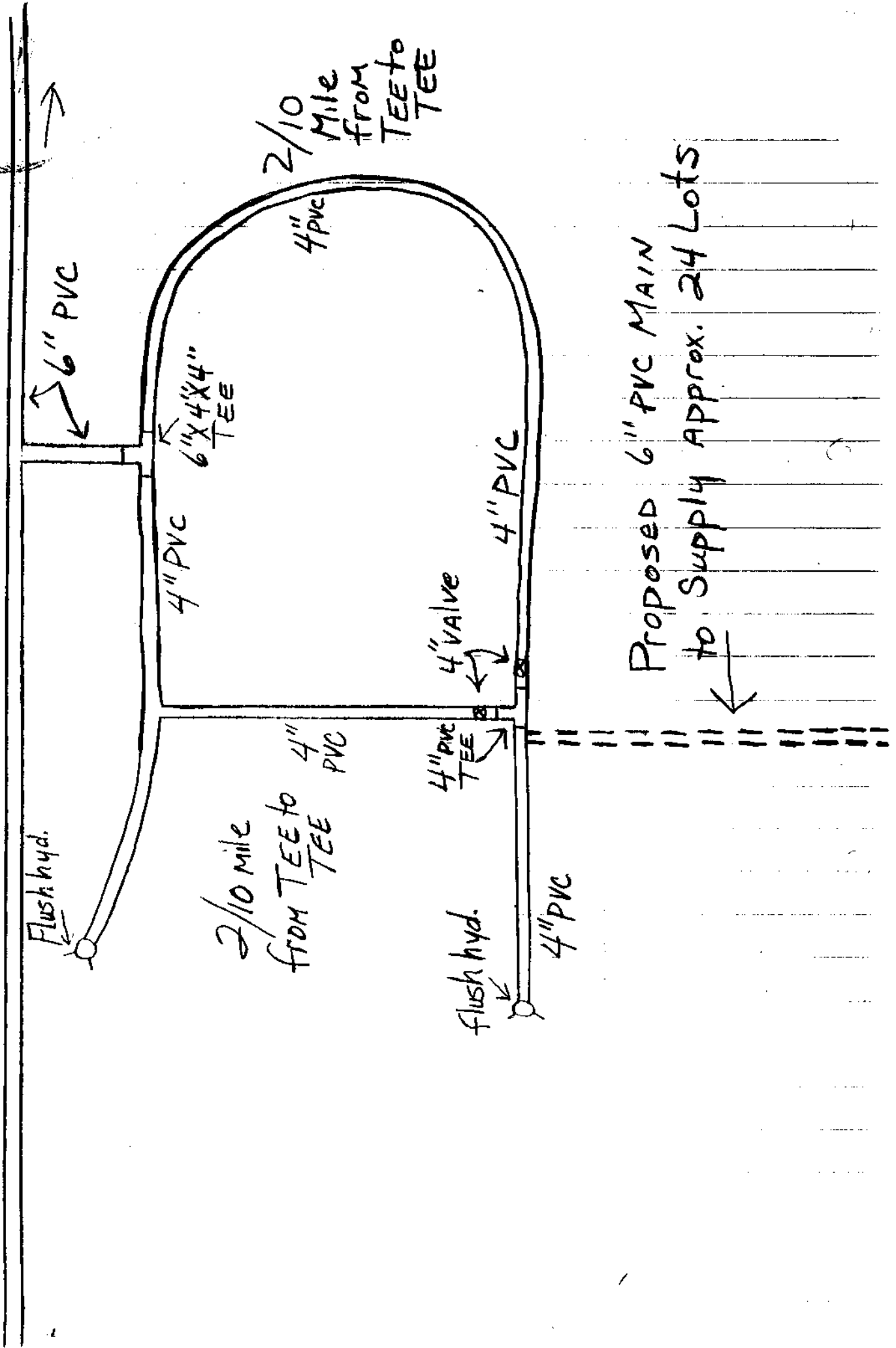

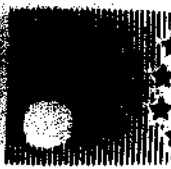
