**RESOLUTION CONCERNING LAW ENFORCEMENT ACTIVE  
SHOOTER EMERGENCY RESPONSE, TRAIN THE TRAINER  
TRAINING FOR THE GREENVILLE MARSHAL DEPARTMENT OF THE  
TOWN OF GREENVILLE, INDIANA**

WHEREAS, the Town Council for the Town of Greenville, Indiana, is desirous to provide the Greenville Marshal Department of the Town of Greenville, Indiana with appropriate training and;

WHEREAS, Greenville Marshal Department Detective David Moore has requested of the Greenville Town Council to attend the Law Enforcement Active Shooter Emergency Response, Train the Trainer Training at the Indiana Law Enforcement Academy located at Plainfield, Indiana from March 5<sup>th</sup> through March 7<sup>th</sup>, 2013 and;

WHEREAS, this is a cost free course presented by the Indiana Law Enforcement Academy and;


WHEREAS, the only cost incurred by the Greenville Marshal Department shall be lodging, food and fuel;


NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF GREENVILLE, INDIANA, AS FOLLOWS:

1. The Greenville Marshal Department Detective Moore shall be authorized to spend the amount N.T.E. \$ 400.00 U.S. Dollars {\$ 400.00} for Lodging, Food and Fuel for the Law Enforcement Active Shooter Emergency Response, Train the Trainer Training at the Indiana Law Enforcement Academy located at Plainfield, Indiana from March 5th through March 7th, 2013.
2. Pre-approval was received by three Council Members for this expenditure due to registration cut-off date being March 5<sup>th</sup>, 2013 and only one student position being available {Council President Talbotte Richardson, Council Woman Patti Hayes, Council Vice President Greg Redden}.
3. The Greenville Town Clerk shall charge as a credit against Law Enforcement Training Acct. No. 233001399 the total cost of this expenditure.
4. Credit shall be reflective on the Monthly Budget Sheet handed out at the April 8<sup>th</sup>, 2013 Monthly Meeting.

This training is for local or state law enforcement officers. This course addresses technical aspects of planning and implementing a rapid law enforcement deployment to an active shooter incident. This is achieved through classroom presentations, hands-on performance-based field training and scenario-based practical exercised.

Participants of the train-the-trainer course should have prior instructional experience and knowledge of instructional methodology and should have instructor certification by the authority having jurisdiction. Prerequisites recommended for this course is ICS 100, 200, and 700 which can be taken at <http://training.fema.gov/IS/crslist.asp>.

Registration is done through the "Acadis" system.
