**ORDINANCE TO ESTABLISH THE POSITION OF MARSHAL'S
DEPARTMENT AUXILIARY MEMBER AND CHAIN OF
COMMAND FOR THE TOWN OF GREENVILLE, INDIANA
MARSHAL DEPARTMENT**

WHEREAS, the town council for the Town of Greenville, Indiana, in the interest of public health, safety and welfare has deemed it necessary that the Town develop an Ordinance which establishes the position of Marshal's Department Auxiliary Member for the Town of Greenville, Indiana Marshal's Department;

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF GREENVILLE, INDIANA, AS FOLLOWS:

1. The position of Marshal's Department Auxiliary Member shall be created upon passage of this Ordinance and be effective on the date of passage of this ordinance.
2. The position of Greenville Marshall Department Auxiliary Member is a voluntary position without any paid compensation or insurance benefits.
3. Marshall Department Auxiliary Member whom request or are asked to become a Marshal Department Auxiliary Member shall sign an agreement with the Greenville Marshal Department waiving any liability of the Greenville Marshal Department and the Town of Greenville for loss of personal property and personal injury to include the loss of life while serving as an Auxiliary Member of the Greenville Marshal Department.
4. The position of Greenville Marshal Department Auxiliary Member is a voluntary position only. Auxiliary Members shall have no arrest powers or marshal powers.
5. Auxiliary Marshal Department Members shall have certain equipment required by the Greenville Marshal Department. The Auxiliary Marshal Handbook shall describe the required equipment and the use of the equipment.
6. The Auxiliary Marshal members shall be allowed to carry a weapon or firearm pursuant to their personal protection permit. The Auxiliary Marshal Department Members shall not be allowed to use their weapon or firearm in the course and scope of their assigned duties; however, the member may use

their weapon or firearm in response to their own personal protection and pursuant to Indiana law.

7. Greenville Marshal Department Auxiliary Members shall be activated upon the authority of the Greenville Town Council President, his designee or the Town of Greenville Marshal under the following circumstances only if they occur within the Town of Greenville Corporate Limits:
 1. natural disaster;
 2. special events;
 3. traffic accidents.

8. After passage of this Ordinance, it shall become an addendum to the Marshal Manual 2009-M-030. Copies to be added to each Marshal Manual that has been issued.

9. The chain of command for the Marshal Department shall be as follows:

Greenville Town Marshal

Greenville Marshal Department Detective

Deputy Greenville Town Marshal

Reporting directly to the Greenville Town Marshal and acting under the arrest powers of the Greenville Town Marshal any Greenville Marshal Department Reserve Members

Reporting directly to the Greenville Town Marshal with no arrest powers or marshal powers allowed the Greenville Marshal Department Auxiliary Members.

10. The Auxiliary Marshal Handbook shall be prepared and maintained by the Greenville Town Marshal. The Greenville Town Board shall approve the Auxiliary Marshal Handbook.

11. The Greenville Town Board shall be required to protect the Town of Greenville by either purchasing liability insurance or requiring the Auxiliary Marshal Department provide appropriate liability insurance naming the Town of Greenville as an additional insured.

12. The Greenville Marshal's Department Auxiliary may raise funds to support the Greenville Marshal's Department. Said funds shall be transferred to the Town of Greenville in an account designated by the Greenville Town Board
