
WHEREAS, the Greenville Municipal Water Utility Council Majority agrees for a merit increase for Municipal Water Utility Superintendent Steven Schmitt effective January 1, 2017 for the period until January 1, 2018.

THEREFORE, BE IT ORDAINED AS FOLLOWS:

1. Water Utility Superintendent position is a salary position.
2. Water Utility Superintendent Steven Schmitt is increased from rate of \$1,190 per week (\$29.75 per hour) to the new salary of \$1,196 per week (\$29.90 per week).
3. Rate is adjusted to reflect 8 hours of guaranteed over-time per week.
