MINUTES OF TOWN COUNCIL MEETING
JANUARY 15, 2002

The regular monthly meeting of the Greenville Town Council was called to order by Council President Ted Miller with Council Members L. Ray Gibson, Hanzel Barclay and Mike Receveur present; David Matthews was absent due to work assignment. Also attending was Jef Fifer, attorney, Gary Getrost, David Moore, Marshal, Mark Trail, Sheila Moore, Deputy Clerk, and Clerk Treasurer Jack Sprigler

Ted Miller apprised members of a probable complaint that may be filed against the Water Utility concerning contamination of a creek located by the old water treatment plant on Voyles Road. Gary stated Bud Ollis, land owner claims there is contamination coming from a once used lagoon. Jef Fifer stated that since the Utility is no longer the owner there is no liability for the Utility. Gary also stated that at the time of sale, a clean up of the area was made by D. Cristiani Excavating in response to I.D.E.M. guidelines.

The Council took up final reading of Ordinance G 2001 - T - 15 titled "An Ordinance Vacating a Public Alley". After receiving a motion to accept the reading, Mr. Miller asked for a vote - L. Ray Gibson, Hanzel Barclay and Mike Receveur voted "Aye" - Miller then cast an "Aye" vote and declared Ordinance G 2001 - T - 15 duly passed and adopted by the Town Council.


Council approved claims for the Town & Utility 4-0.
