Minutes of Greenville Town Council Meeting January 11th, 2010

Council President Talbotte Richardson called the regular monthly meeting to order. Other Councilpersons present were Bob Wright, James Pearce and Randal Johnes, along with Clerk Jack Travillian. Also attending the meeting were Water Utility Superintendent Gary Getrost, town attorney Rick Fox, and other concerned citizens. Chaplain Mark Avery opened the meeting with a prayer, followed by the Pledge of Allegiance.

Minutes: President Richardson made a motion and Councilman Johnes seconded to accept the December 14th monthly minutes as revised by Councilman Johnes. Motion passed 4-0. Motion was made by Councilman Johnes and seconded by Councilman Wright to accept as written the minutes from special meeting of December 28th, 2009. The council voted to approve 4-0.

Councilman Johnes read the following confirming Resolution made in the December 14th, 2009 Monthly Meeting; **Resolution 2009-R-085** RESOLUTION CONFIRMING THE VERBAL RESOLUTION PASSED IN THE MONTHLY MINUTES OF THE TOWN OF GREENVILLE DATED 12-14-2009 FOR THE ENGINEERING SURVEY OF CLARK STREET LOCATED WITHIN THE TOWN OF GREENVILLE, INDIANA CORPORATE LIMITS; **Resolution 2009-R-087** RESOLUTION CONFIRMING THE VERBAL RESOLUTION OF DENIAL FOR CODE VARIANCE FOR PROPERTY WITHIN THE TOWN OF GREENVILLE, INDIANA **Resolution 2009-R-083** RESOLUTION DOCUMENTING THE CASHING OUT OF CD 32127 OWNED BY THE TOWN OF GREENVILLE, GREENVILLE, INDIANA **Resolution 2009-R-086** RESOLUTION CONFIRMING THE VERBAL RESOLUTION TO PURCHASE A LIGHT BAR FOR THE GREENVILLE'S MARSHAL DEPARTMENT JEEP FOR THE TOWN OF GREENVILLE, INDIANA Councilman Johnes noted that this resolution was discussed but never voted on, therefore he made a motion and President Richardson seconded, to accept the resolution as written. Motion passed (4-0). Councilman Johnes requested that all votes in the future be confirmed by raising of the right hand, for visual confirmation. Council agreed. Attorney Fox requested that the vote be verbally stated after completing for the recorded minutes.

Presentation of 2009 Citizen of the Year Award; President Richardson honored (Chester) Butch Richardson with the 2009 Citizen of the Year Award for all the work done on a presentation concerning water drainage on the Indiana Department of Traffic Highway 150 widening project. The presentation helped point out problems with the initial project drawings that did not consider water runoff and helped the council get a review ordered by the Governor's staff.

Marshal's Report:

The marshal's department has written 40 traffic tickets in the past month, however there has been problems with the Floyd County Clerk's Office and there was no credit given for the tickets for funding. That problem has hopefully been resolved. The department is

responding to a lower number of domestic runs but has continued to have an increase in backup calls for the Floyd County Sheriff's Department.

The officers are trying to complete the mandatory twenty-four (24) annual training before the end of February.

Marshal Moore pointed out that the town police officers are as much at risk any state, county or local officer, therefore he would like the town to add life insurance for every officer including reserve officers. Councilman Wright is working with Clerk Travillian to get bids to have this occur.

Councilman Johnes excused himself because of illness and left the meeting.

Water Business:

Superintendent Getrost submitted monthly adjustments to the council. The board approved the adjustments for the bills (3-0).

Pumping station in Galena: Superintendent Getrost reported that the pit has been completed for the pumping station in Galena.

Hydraulic Study: Superintendent Getrost reported that he has signed a contract with Jacobi, Tomes, & Lanz for a hydraulic study for the service area of the Greenville Municipal Water Utility.

Service Charges Ordinance: Superintendent Getrost reported that some local water utilities are sharing their current service charge ordinance with him. This should help give a blue print for writing an adequate ordinance for the Greenville Municipal Water Utility.

Resolution 2009-R-082 ORDINANCE FOR MERIT INCREASES FOR WATER UTILITY EMPLOYEES FOR THE YEAR 2010 OF THE GREENVILLE MUNICIPAL WATER UTILITY OF GREENVILLE, INDIANA. Second reading, Councilman Wright made motion to accept the ordinance and President Richardson seconded. Motion passed 3-0. Third reading was completed and a motion was made by Councilman Pearce, seconded by President Richardson. Motion passed 3-0.

Financial:

Review/Approval Checks and Expenditures: Clerk Travillian presented the forms for the checks written from the utility and the town. Clerk Travillian stated that the town checks were not including December's checks because of a software issue. The required paper work will be ready for next month's meeting.

Attorney Report: Attorney Fox requested a copy of the incorporation papers setting up the Greenville Municipal Water Utility. Clerk Travillian and the water clerk's staff will review files looking for the requested files.



TOWN OF GREENVILLE
ORDINANCE NO. 2010-T-001

ORDINANCE TO ESTABLISH A WATER UTILITY
BY THE TOWN OF GREENVILLE, INDIANA

WHEREAS, the town council for the Town of Greenville, Indiana, has developed an Ordinance to establish a Water Utility by the Town of Greenville;

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF GREENVILLE, INDIANA, AS FOLLOWS:

1. The Greenville Town Board pursuant to IC. 8-1.5-3-3(a)(2) hereby establishes the Greenville Water Utility. In support of said ordinance, the Greenville Town Board states as follows:
2. That I.C. 36-9-2-14 states that "A unit may regulate the furnishing of water to the public. A unit also may establish, maintain and operate waterworks.
3. That I.C. 8-1.5-3-3 states that "The legislative body of a municipality may, by ordinance, provide for the control of any or all of its municipally owned utilities by: (2) a board consisting of the members of the municipal legislative body.
4. That the Town of Greenville, in Ordinance No. W-3, adopted a schedule of rates and charges for the services to be rendered by said waterworks upon the completion of construction of the same and the beginning of operation of said waterworks as a municipal utility, which rates and charges must be sufficient to enable the Town properly to operate the waterworks system, provide for depreciation, and finance the construction of said system.
5. That pursuant to Ordinance No.-1994-02, the Town of Greenville on June 7, 1994, adopted an ordinance which states in part: That the Town of Greenville's water utility be removed from the jurisdiction of the Indiana Utility Regulatory Commission for approval of rates and charges and of the issuance of stocks, bonds, notes, or other evidence of indebtedness.
6. Hereby this Ordinance 2010-T-001 establishes the Greenville Water Utility.
