MINUTES OF TOWN COUNCIL MEETING

March 10, 2003

The regular monthly meeting of the Greenville Town Council was called to order by Councilmember Ted Miller who presided in the absence of Council President L. Ray Gibson; Councilmember Hanzel Barclay was also absent. Councilmembers David Matthews and Mike Receveur and Clerk Treasurer Jack Sprigler was present.

Also attending was Gary Getrost and Janice Gibson (Utility employees), Marshal David Moore, Jef Fifer and Denise Franke of Fifer Law Office and Town resident Bill Smythe.

Mike Receveur motioned the February minutes be approved as written with the following additions/corrections:

"Council gave 1st and 2d reading to Ordinance 2003-T-025 titled: AN Ordinance establishing, Implementing, and, Enforcing Standards, Regulations, and Rules Concerning the Maintenance, Repair, and/or Removal of any Structures Constituting a Hazard to Public Safety, Health and Welfare". "On call of the roll Council President Ray Gibson, Councilmembers Ted Miller, David Matthews and Mike Receveur voted "Aye" to accept the Ordinance and to hold a Public Hearing prior to the March meeting at which time the Council will vote".

Council approved the above by a vote of 3-0.


Ted Miller then stated the hearing on Ordinance 2003-T-025 was open for discussion and comments. There being no one in attendance for the hearing and since Council did not receive any comments, suggestions and/or criticism in writing Miller then introduced Ordinance 2003-T-025. Receveur motioned the Council accept the Ordinance. On call of the roll all Councilmembers present voted "aye". Miller then declared Ordinance 2003-T-025 duly passed by the Greenville Town Council after final vote of 3-0.

David Moore apprised the Council he had attended a meeting of the County Commissioners regarding the Animal Control situation. He stated the County will pay Greenville's portion of an assessment being currently requested by Animal Control.

Gary Getrost presented the Council customer water bill adjustments and an update on funds received from the State for the US150 project.
