MINUTES OF TOWN COUNCIL MEETING

MARCH 13, 2001

The regular monthly meeting of the Greenville Town Council was called to order by Council President Ted Miller at 7:30 p.m. with Council Members Ray Gibson, Hanzel Barclay, and Mike Receveur present; David Matthews was absent due to work schedule. Also attending was Clerk Treasurer Jack Sprigler, Utility Supt. Gary Getrost, John Leachman (Fifer Law Office), J. I. Lanz, P.E., A. Sutherland (Jacobi Toomes & Lanz), David Moore, Nike Arnold, and T. Skees.

Minutes of the February meeting was approved (4-0) after motion by Mike Receveur to dispense with the reading and approve.
