Terry Boaz opened the meeting. All members, Charles Birkla and a visitor were present. The minutes from the last meeting were read and approved. Claims were presented and approved for payment. The treasurer's report as of March 31, 1973 shows a total balance of \$6,130.16, (General Fund \$418.32; Street Fund \$3,603.30; CCIF \$2,108.54.) Our Revenue Sharing Fund has \$125.00 in checking and a 3 month Certificate of Deposit for \$3,500.00. Farnsley Burkhart's water report for February agrees with the bank statement.

Gary Jacobi reported a scheduled meeting with Mr. Bockman for April. The Board wishes to have three (3) areas checked for possible rebuilding of streets. The three (3) areas are 1st Street from U.S. 150 to the Christian Church, continue Clark street to or beyond the water tower and then over to U.S. 150, and continue Harrison Street to the Park. Charles Birkla and Donald Uhl will attend this meeting if possible.

Midwest Engineers have completed our plans for equipment for the fluoridation of our water.

Charles Birkla reported some tree tops that were cut from the Ronald Webb property have fallen into the lake. Mr. Birkla is to see if those responsible would remove such tree tops.


David Neel requested the water company to assume ownership of approximately seven hundred (700) feet of water lines to his house and that we install another water meter for a new house. All agreed to his proposal.

A RESOLUTION OF THE TOWN OF GREENVILLE, INDIANA  
BOARD OF TRUSTEES  
RELATIVE TO THE INTRODUCTION OF FLUORIDES INTO THE  
PUBLIC WATER SUPPLY

WHEREAS investigations by competent dental, medical and public health authorities show that the presence of fluoride in drinking water is a deterrent to tooth decay; and

WHEREAS laboratory analysis shows that such chemical substance in optimum quantities is not found naturally in the public water supply of THE TOWN OF GREENVILLE, INDIANA; and

WHEREAS Regulation HSE 2 of the Indiana State Board of Health permits the addition of certain fluoride compounds to public water supplies within controlled limits;

THEREFORE BE IT RESOLVED that Terry Boaz, Town Trustee, is hereby authorized and directed to have plans and specifications prepared for the purchase and installation of equipment to add sodium fluoride to the water being distributed by this water utility and to submit them to the Indiana State Board of Health for approval; and

BE IT FURTHER RESOLVED that, upon the approval of these plans and specifications by the Indiana State Board of Health, such equipment and supplies be purchased and installed in the manner provided by state law, and that thereupon said fluoride compound be added to the public water supply in sufficient quantities to bring the total amount of fluoride ions (F-) present in the finished water to the optimum concentration recommend by the State Board of Health but not exceeding 1.5 parts per million by weight.
