Minutes of the March meeting and the March financial statements were presented to and accepted by each board member.


Floyd Central High School wants to install and maintain their own Water Meter, Greenville Water Utility will read the meter.

The Board instructed the Water Utility to enforce the Ordinance (set at the time of the rate increase) that requires a summer minimum, according to the size of the Schools water meter.



During the month of December 1982 I received numerous calls about stray dogs. By mid-February the problem had worsened. The dogs had formed packs and were killing small animals in and around Greenville. One night in mid-Feb. 1983 two men came to me and were very upset over the fact that one of their dogs, while chained up in the back yard, had been attacked by a pack of dogs and had been severely mauled with a Vet. bill in excess of \$75.00. I told the men that they had the right to protect their property and that if the dogs returned they had my permission to use firearms to do so. Two nights later the dogs returned and one of them was killed as a result. Following this incident Butch Richardson called 7 times about a pack of dogs keeping him awake

at night. Rita Tush called and said she had been attacked by a dog after coming out of her house. Tony Denton said he had been surrounded by a pack of dogs at the corner of Coffman and Pekin Rds. and had to get a stick to ward them off. Barry Jenkins reported that his dog had been killed by a pack while chained to a dog house. Minnie Meredith reported a pack of dogs hanging around her place on Pekin Rd. And Gladden Boag told Don Jackson that every time he left his house he was aggravated by a stray dog growling at him. At this time some of the dogs have been destroyed. Due to the timing and the circumstances involved, your help and understanding in this matter will be greatly appreciated.

8-5400 I went to see Paul Badger (Floyd County Sherrifs Dept.) and explained to him about the dogs. Paul said he did not think anyone should be firing a gun in Greenville. Dogs are a never ending problem, but he did not know what to do. Paul said as long as he has been on the Police Dept. he had only shot two dogs and both of them had been hit on the highway. What they do is contact the city dog pound. He tried to contact the Floyd Cty. Prosecutor but he was not in. Badgers recommendation was: 1. Do we have an ordinance on dogs? 2. Do we have an ordinance on the discharging of fire arms in Greenville. 3. Be sure and contact someone in case something was to happen we would be covered.

Steve Hash, conservation officer, said he could not do anything with dogs but he could with coyotes.

Called Max Mason, he said he heard a little of our conversation and he was in agreement about shooting in Greenville. And seeing if we could get help was the right way to go.

#948-5355 Called Animal Shelter, New Albany. They do not go out of the city limits of New Albany and the only advice they could give is to contact the County dog pound.

Called Paul Badger at the Floyd County Sherrifs Dept. Paul said he had talked with the county prosecutor Nick Stein. Stein said we were under the same as the state ordinance and really he could not give any advice.

#945-4478 Animal Rescue League - could not get an answer.

#283-6526 Humane Society, Clark Co.- Talked with Mrs. Flynn. She did not like the idea of shooting dogs but could not give any advice other than call Clark County Animal Shelter.

#282-0071 Clark County Animal Shelter - Talked with Mrs. Hunter. She did not like the idea of shooting the dogs but could not give any advice.

Dear Ms. Gibson:

We have reviewed the forms submitted to this department with your letter dated February 24, 1983, and we are approving the following forms for use with your F-85 Durango Computer, in Town of Greenville, Indiana, with the conditions noted.

Forms:

1. Meter Reading Edit
2. Pre-bill Register
3. Accounts Receivable Transactions - Cash Receipts
4. Accounts Receivable Transactions - Penalty Charges
5. Accounts Receivable Transactions - Adjustments/Late Charges
6. Aged Accounts Receivable Journal
7. Disconnect Notice

Conditions:

1. Accounts Receivable Transactions-Cash Receipts should separate payments for current bill, sales tax, penalty.
2. Aged Accounts Receivable Journal-should give total by age group.
3. We have reviewed the General Ledger Profile (Dated January 28, 1981) and find it to be generally acceptable. When forms or printouts are developed for Greenville, we will conduct another review. We will need (1) the Chart of Accounts for the accounting system; (2) a different format should be developed for the Standard Journal Transaction Register to relate Debits and Credits for an entry; (3) for General Ledger Trial Balance, we need to know how long can detail be accumulated, proposed formats for check register and cash receipts register; (4) General Ledger Source Cross Reference does not balance.
