The regular monthly meeting of the Greenville Town Board, held this date, was called to order by President H. L. Spears. All Board members were present. Also attending: Gary Getrost, Janice Gibson, Pat Houghlin, Bud Ollis, Paul Buche, and Mrs. Hankin.

Ron Lamb moved to dispense with the reading of the minutes. Jack Sprigler seconded. Financial statements and claims were presented to the Board. The claims were approved and the financial statements accepted by the Board.

Bud Ollis asked why Bernie Leuthart doesn't have to mow his property. The Board will send a registered letter asking Mr. Leuthart to mow.

The Board informed Paul Buche, as a representative of the Marshal's office, of complaints on the lack of visibility of the Marshal's car, the speed of vehicles through town, and young people congregating at the market parking lot.

Mrs. Hankin inquired about extending water to some property on Featheringill Road. Gary will check the layout and get back to her. The Board told her that normally the landowner hires his own contractor to extend the line to his property. A 6" main should be used for any new extension.

The Board informed Pat Houghlin it will not, at this time, pass the ordinance establishing building code regulations or a zoning ordinance.

The Board discussed the problems connected with fishing at the lake - trying to find a solution satisfactory to both the water utility and the fishermen. The Board told Gary to contact Roy Kessinger, who owns the property with the road to the lake, for his views on the matter.

The yellow truck has not yet been sold. The Board told Gary to find out what the "book" rate is on it.

There being no further business, Jack Sprigler moved the meeting be adjourned. Ron Lamb seconded.
