#### MINUTES OF TOWN COUNCIL MEETING July 9, 2002

The regular monthly meeting of the Greenville Town Council was called to order by Council President Ted Miller with Council Members David Matthews, Hanzel Barclay and Ray Gibson present - Mike Receveur was absent due to work. Also Attending was Clerk Treasurer Jack Sprigler, Attorney Jef Fifer, Administrative Clerk Sheila Moore, Utility Clerk Janice Gibson, and Marshal David Moore.

Others present were Jerry Burkhart and John & Jennifer Hockensmith.

Minutes of the June 11 meeting was approved on motion by Hanzel Barclay (4-0).

Mr. Hockensmith presented prints of the territory to be annexed along with a letter from So. Indiana Abstract Co. revealing the roadway to his property to be annexed was in the Town limits. Attorney Jef Fifer stated a public hearing will need to be held prior to the August Council meeting and that it be advertised at least ten (10) days prior to the meeting at which time the Council will consider an Ordinance of Annexation. Fifer suggested Hockensmith contact his attorney to advertise the public hearing and prepare the annexation ordinance.

The Council also approved (4-0) a fee system for anyone requesting annexation into the Town of Greenville. This fees will include: advertising costs - per newspaper charges and Ordinance preparation filing fee - per Auditor & Recorder charges. Above fees will be charged to a company or an individual.

Jerry Burkhart stated he needed a copy of the alley vacation as pertaining to his current residence at Clark Street. Also the Council approved 4-0 the wavier of a meter installation fee of \$450.00, for a new home Burkhart is building on Arthur Coffman Rd. since there is currently a double set hook-up. He will pay only the \$500.00 surcharge.

David Matthews presented the Council with a "Codified Statues of the Town of Greenville, Indiana" for Council consideration. After review the Council directed Matthews to proceed with further Codification.

Marshal David Moore advised the Council he applied for a training grant through the ISP.
