MINUTES OF TOWN COUNCIL MEETING July 11, 2000

The regular monthly meeting of the Greenville Town Council was called to order by Council President Ted Miller @ 7:30 PM at the Town/Utility office.

Call of the Roll- Council Members David Matthews, Hanzel Barclay, L. Ray Gibson, and Mike Receiveur were present and Clerk Treasurer Jack Sprigler.

Also attending was attorney Jef Fifer, Janice Gibson, Gary Getrost. David Moore and David Decker.

Minutes of the June meeting were approved after motion by Mike Receveur (5-0)

David Decker advised the Council he was going to be build (2) houses on West Harrison Street(Lots 9.10,31, & 12) and that he has a permit for a septic system for each house approved by the Floyd Co. Health Dept. The water line servicing this area is a 1" line-which may or may not be sufficient. Gary will work with Decker regarding any line extension/change.

Jeff Fifer presented an Ordinance to the Council concerning trash and abandon vehicles. Council President Ted Miller accepted the Ordinance titled "An Ordinance Concerning the Disposal of Trash and Abandon Vehicles on Real Property within the Town of Greenville. Indiana" on motion by Mike Receveur and vote of the Council (4-0). After readings and review of Council each Council member voted "Aye". President Miller then declared Ordinance 2000-04 duly passed and enacted.

The Council, after reading and review, gave final approval of Ordinance 2000-03 titled "An Ordinance Regulating Outdoor Advertising". Each member voted "aye". Miller then declared Ordinance 2000-03 duly passed and enacted.

Gary advised the Council the Greenville Masonic Lodge had a usually high water bill and was approached by the lodge for an adjustment. When a user has a water leak such adjustments are common; but the high usage at the Lodge cannot be traced to a leak or if for some other reason. The Council, aware of this situation and after careful review, approved and adjustment of \$111.05 and the remaining balance of \$198.78 be paid over a six (6) month period, if the Lodge wishes.
