The regular monthly meeting of the Greenville Town Board, held this date, was called to order by President H. L. Spears. All Board members were present. Also attending: Gary Getrost, Janice Gibson, Bob Isgrigg, Scott Ham, Bob Williams, Talbotte Richardson, and Paul Buche.

The minutes were read and corrected to show the salary for Scott Ham. Financial statements and claims were presented to the Board. The claims were approved and financial statements accepted by the Board.

Bob Isgrigg told the Board his sewer plan would cost the Town approximately \$240,000.00 for 250 units with operating costs of about \$25,000.00 per year. The system would require about 6.5 acres of water area. Ten acres of land would be adequate.

Gary Getrost reported that Edwardsville Water Company has notified him they are ^{contemplating} raising the rates from \$.67 per 1000 gallons to \$.92 per 1000 gallons.

The State Board of Health has visited about the new EPA standards on turbidity. It is to be below 0.1. The law is to take effect this month with an 18 month grace period.


The State Board of Health did a flow test on both sides of the planned connection with Floyds Knobs Water Company. Once we have their approval, construction can begin.

The Board announced that Water Utility employees (with the exception of Scott Ham) will receive a 2% raise. After this year raises will be on a merit basis.

The problem of hydrant rental in Greenville Township has still not been resolved. The Board authorized Bob Isgrigg to arrange for ariel photos to be taken of the water lines.

There being no further business the meeting was adjourned.
