

MINUTES OF TOWN COUNCIL MEETING OF DECEMBER 15, 1992 FOR GREENVILLE, INDIANA

The regular monthly meeting of the Greenville Town Council was called to order by President Ron Lamb at 8:00 P.M., with all Councilmembers and the Clerk Treasurer in attendance. Also attending was Butch Richardson, Fred Marsh (SEICO), Gary Getrost and Janice Gibson.

Minutes of the November meeting was approved as was the claims for the town/utility.

The Clerk Treasurers' report indicate bank balances appear to be correct.

The Council approved the surrender of Certificates of Deposit as they come due for the Operating Fund in order to alleviate the cash flow problem.

The Council gave 1st and 2d reading of an Ordinance Redistricting Wards within the Town of Greenville, Floyd County, Indiana by a vote of 3-0. Third reading was voted on by the Council for final approval by a vote of 3-0.


The Council voted 2-0 to elect Ron Lamb as the incoming President for the year 1993.

Butch Richardson inquired as to the status of the Agreement between the Town and Pearce Bottle Gas (Highland Natural Gas Co.). Ron Lamb informed Mr. Richardson that he had not heard from the attorney, but would call him for information. Council stated they hoped this information would be available at the next meeting.

Fred Marsh presented the Council with a map of proposed water collection/distribution system for the utility. Mr. Marsh stated SEICO requests the Town to approve the findings of his proposal in order for SEICO to present its findings to the Utility Regulatory Commission. After deliberation the Council voted 3-0 to have Mr. Marsh proceed with these findings.

The Council voted 3-0 to relieve Talbott Richardson as Marshall effective December 31, 1992. This action was made necessary in order that Council can review current and future laws and regulations regarding the position of Town Marshall.
