MINUTES OF TOWN COUNCIL MEETING

December 15, 2003

The regular monthly meeting of the Greenville Town Council was called to order by Council President L. Ray Gibson with Councilmembers David Matthews, Hanzel Barclay, Ted Miller present; Raymond Receveur was absent and Clerk Treasurer Jack Sprigler also present.

Also attending was Utility Supt. Gary Getrost, newly elected officials James McKown, Janet Wright, Jack Travillian, Denise Franke, David Moore and other interested persons.

Minutes of the November meeting was approved as written on motion by Ted Miller.

Denise Franke apprised the members of necessary action to be taken regarding the Meador property currently being considered unsafe by the Council. The Clerk Treasurer was directed to send Notice Via Certified Mail-return receipt to Mr. & Mrs. Meador advising them of a hearing to be conducted at the January 2004 meeting.

The Council voted 4-0 to hold a public hearing on proposed water rate increases for January 12, 2004 at 7:30 PM.

Gary presented the Council with a revised SOP regarding water meter installations. The Council adopted the SOP by a vote of 4-0.

Council approved water bill adjustments, claims for the Town & Utility and the hiring of Brad Getrost as Temporary at 7.50/hr. 4-0.

Council approved Ordinance 2003-T-031 titled "An Ordinance Establishing Salary for the Town Marshal" by a vote of 4-0.

Council approved 4-0, Ordinance 2003-W-032 titled "An Ordinance Providing for the Wages for Employees of the Town of Greenville Water Utility".


Council voted 4-0 to change the street within Greenville from US150 to E. Harrison St. to "Jack Sprigler Drive".

Ted Miller motioned the Council recognize the accomplishments of outgoing Council President L. Ray Gibson for his years of service to the Town.

No further business coming before the Council the meeting was adjourned.


