Minutes of Greenville Town Council Meeting April 13th, 2020

President Greg Redden called the regular monthly meeting to order via Zoom meeting. Other Councilpersons present were Andy Lemon, David Gomes, Kyle Kruer and Skip Powell along with Clerk Jack Travillian. Also attending the meeting were Town Attorney Heather Peters, Greenville Water Superintendent Audi Findley.

Minutes: The minutes for March 9th regular meeting and special meeting were discussed. Motion was made by President Redden and seconded by Councilman Lemon to accept the minutes. Motion passed 5-0.

Police Report:

Chief Craig unavailable. Councilman Gomes noted that one cruiser needed tires, which would be done by the Floyd County Maintenance Garage, and another needed air conditioner work, to be completed by John Jones Automotive. Motion made by Councilman Lemon and seconded by President Redden to have these completed and paid for from the Riverboat Fund. Motion passed 5-0.

Councilman Gomes requested a backup camera system be installed in the K-9 patrol vehicle at a cost of between \$125 up to \$300. The request was tabled until next month.

Police Chief Craig has reported that the department has received a donation from Walmart for \$250.

There is a request to drive to Indianapolis in a police cruiser with two officers on Thursday for the fallen officer from Indianapolis. The council had no objections.

Financial:

Review/Approval Checks and Expenditures: Clerk Travillian presented the forms for the checks written from the utilities and the town. The checks were approved. Motion made by President Redden and seconded by Councilman Lemon for reconciling form for February 2020. Motion passed 5-0.

Committee Reports:

Streets and Roads:

Councilman Lemon is working with INDOT on the CCMG grant. The Pot Hole Blitz has been completed. Councilman Lemon reported that most of the additional signage has been completed. The tree removal and brush removal has been completed.

Superintendent Findley reported that Streigel Paving does not do seal coating for streets, he will be checking with other paving companies in the area.

Special Projects:

The sidewalk construction at Town Hall on Cross Street has been completed. The town is providing free public WIFI during this Covid 19 pandemic.

Attorney report:

There has been a garbage collection truck picking up dumpsters in Heritage Springs at 5:30. Attorney Peters will be sending a citation and will follow up with the police department about citing the individual driver.

The Stellar Community Grant work has been completed and awaiting participation with Floyd County and Georgetown to apply with the State of Indiana.

Ordinance 2020-TO-006 - AMENDMENT TO ORDINANCE 2010-T-056 CONCERNING THE REGULATING OF ANIMALS AND ANIMAL CONTROL WITHIN THE TOWN OF GREENVILLE, INDIANA Ordinance adding “Animals running at large” requiring leash on all animals. Second reading of the additions to the ordinance were read and motion was made by President Redden and seconded by Councilman Kruer. Motion passed 4-1. Councilman Powell voted against. Third reading was completed. Motion was added by President Redden and seconded by Councilman Gomes. Motion passed 4-1. Councilman Powell voted against.

Utility Business:

Water Utility

Superintendent Audi Findley sent his monthly report to the council before the meeting and there was no questions. The loss rate is running higher than anticipated, the staff will be doing more investigating. The leaks and adjustment report was presented and accepted with no questions.

Superintendent Findley presented an estimate for running CAT cabling to the garage at \$2,500. The council requested additional bids.

The council will be responding the Edwardsville Water red line contract. The council will reply with up to a 20 year contract with and an escape clause, to be reviewed by Attorney Peters.

Sewer Utility:

Superintendent Findley reported that new ultra violet lights have been installed at the sewage plant.


There will be a special meeting concerning the Water Tower maintenance contract to be held on April 27 at 6:30 on Zoom.
