

Minutes of Greenville Town Council Meeting August 11th, 2014

Council President Talbotte Richardson called the regular monthly meeting to order. Other Councilpersons present were Greg Redden, Bob Wright, and Darryl Kepley along with Clerk Jack Travillian. Also attending the meeting was town attorney Chris Lane and a few concerned citizens. The meeting was opened with a prayer from Pastor Avery followed by the Pledge of Allegiance.

Minutes: The minutes for July 14th regular meeting and July 14th public hearing were discussed. Motion was made by President Richardson seconded by Councilman Redden to accept the proposed minutes with amendments. Motion passed 4-0.

Financial:

Review/Approval Checks and Expenditures: Clerk Travillian presented the forms for the checks written from the utility and the town. The checks were approved without objections. Clerk Travillian presented the council the proposed budget for 2015.

Committee Reports:

Streets and Roads:

Councilman Wright gave a report of roads in need of repair and Greenville/Georgetown Road is at the top of the list, however, the council considers this a Floyd County Road that runs through Greenville and therefore needs to be done at the county's expense. The council will advise any concerned citizen to call the Floyd County Commissioner's office with any complaints about the condition of the paving.

Town Attorney Lane has contacted the Floyd County Commissioners office about the problem of New Albany/Floyd County Animal Control refusing service to our citizens. The Commissioner's office has concerns with the accessibility and are frustrated by lack of progress from that department.

Utility Business:

Superintendent Schmitt was unavailable, so Office Manager Amy Stone submitted the adjustments that were approved without comments.

Councilman Kepley questioned if all new meters had been installed, employee Crystal Robb confirmed that the installation has been completed.

Insurance renewal for Town of Greenville along with the Greenville Water and Sewage Utility by ISU insurance. Motion was made by President Richardson and Seconded by Councilman Redden. Motion passed 4-0.



No further business coming before the Council the meeting was adjourned.


