**RESOLUTION CONCERNING THE APPROVAL OF FUNDS TO OBTAIN
AN INCOME SURVEY FOR A FUNDING GRANT FOR AN
ENGINEERING STUDY FOR THE TOWN OF GREENVILLE, INDIANA**

WHEREAS, the town council for the Town of Greenville, Indiana, in the interest of public health, safety and welfare, has deemed it necessary that the Town develop an Ordinance which authorizes the expenditure of funds for an income survey required by the River Hills Economic Development District & Regional Planning Commission to prepare a grant application for submittal to the Indiana Office of Community & Rural Affairs to receive a federal Grant for the Engineering fees to acquire an Engineering Study for sewers construction within the Corporate limits of the older part of the Town of Greenville;

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF GREENVILLE, INDIANA, AS FOLLOWS:

1. Being that an income survey is required for the grant application, and that River Hills Economic Development District & Regional Planning Commission is certified by the State of Indiana to write such grants and;
2. Being that Dr. Frank H. Wadsworth, Ph. D., CFE, Professor of Marketing and International Studies School of Business, Indiana University Southeast, 4201 Grant Line Road, New Albany, In. 47150-6405 {812} 941-2531 is certified by the State of Indiana to tabulate, analyze and submit those surveys to River Hills Economic Development District & Regional Planning Commission and;
3. Being that Dr. Frank H. Wadsworth, Ph. D. CFE has quoted a price to Councilman Randal Johns to tabulate, analyze and submit survey to River Hills and the Greenville Town Council of seven-hundred fifty dollars {\$750.00}and;
4. Given that the Greenville Town Council has already approved by a unanimous vote the expenditure of seven-hundred fifty dollars {\$750.00} this resolution authorizes the following.
 - A. A copy of this resolution is to be mailed to Dr. Frank H. Wadsworth to be used as a contract document for his services by the Greenville Town Council.
 - B. An excel copy of the addresses for the residences within the older part of the town of Greenville to be mailed to Dr. Frank H. Wadsworth. Dr. Frank H. Wadsworth is to invoice the Town of Greenville @ P.O. Box 188, Greenville, In. 47124 attention Greenville Town Clerk along with income survey analysis.


C. Income survey that is to be provided by River Hills Economic Development District & Regional Planning Commission is to be mailed to the Greenville residents within the older part of Greenville with an enclosed stamped envelope addressed to Dr. Frank H. Wadsworth along with the introductory letter from the Greenville Town Council signed by the Greenville Town Council President, and attested to by the Greenville Town Clerk. The Greenville Town Clerk shall mail these documents to the residences listed on the excel residents list attached.

D. These documents shall be mailed to residents within {5} days after receiving the income survey form from the River Hills Economic Development District & Regional Planning Commission.
