**CONFIRMING ORDINANCE CONCERNING THE APPROVAL OF
CHIEF OF POLICE COURSE TRAINING FOR THE TOWN OF
GREENVILLE MARSHAL OF THE TOWN OF GREENVILLE, INDIANA**

WHEREAS, the Town Council for the Town of Greenville, Indiana, in the interest of providing the Greenville Marshal with the appropriate training to better execute his/her duties for the protection of the Town of Greenville, Indiana and;

WHEREAS, the Indiana Law Enforcement Academy is offering a training course located in Plainfield Indiana that requires a fee for this Course:

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF GREENVILLE, INDIANA, AS FOLLOWS:

1. The Greenville Town Clerk / Treasurer shall issue funds for said cost of course, not to exceed Four Hundred Fifty U.S. Dollars {\$450.00}
2. Charges for the cost associated with this Course shall be charged as a credit against the Cumulative Capital Improvement Inter Fund Operation Account No. 401001520 as authorized per I.C. 36-9-16-3 Sec. 3 {12} {C}.
3. This Ordinance was made verbally by Councilman Johnes in the March 14th, 2011 Monthly Meeting. Verbal Ordinance was seconded by Council President Talbotte Richardson.

IC 36-9-16-3

Cumulative capital improvement fund; additional purposes

Sec. 3. A unit may establish cumulative capital improvement funds to provide money for one (1) or more of the following purposes:

- (1) To acquire land or rights-of-way to be used for public ways or sidewalks.
- (2) To construct and maintain public ways or sidewalks.
- (3) To acquire land or rights-of-way for the construction of sanitary or storm sewers, or both.
- (4) To construct and maintain sanitary or storm sewers, or both.
- (5) To acquire, by purchase or lease, or to pay all or part of the purchase price of a utility.
- (6) To purchase or lease land, buildings, or rights-of-way for the use of any utility that is acquired or operated by the unit.
- (7) To purchase or acquire land, with or without buildings, for park or recreation purposes.
- (8) To purchase, lease, or pay all or part of the purchase price of motor vehicles for the use of the police or fire department, or both, including ambulances and firefighting vehicles with the necessary equipment, ladders, and hoses.
- (9) To retire in whole or in part any general obligation bonds of the unit that were issued for the purpose of acquiring or constructing improvements or properties that would qualify for the use of cumulative capital improvement funds.
- (10) To purchase or lease equipment and other non-consumable personal property needed by the unit for any public transportation use.
- (11) In a county or a consolidated city, to purchase or lease equipment to be used to illuminate a public way or sidewalk.
- (12) The fund may be used for any of the following purposes:
 - (A) To purchase, lease, upgrade, maintain, or repair one (1) or more of the following:
 - (i) Computer hardware.
 - (ii) Computer software.
 - (iii) Wiring and computer networks.
 - (iv) Communication access systems used to connect with computer networks or electronic gateways.
 - (B) To pay for the services of full-time or part-time computer maintenance employees.
 - (C) To conduct nonrecurring in-service technology training of unit employees.
- (13) To purchase body armor (as defined in IC 36-8-4-4.5(a)) for active members of a police department.

In 1987 the Indiana Legislature passed legislation for the Indiana Law Enforcement Training Board to adopt rules under IC 4-22-2 to establish an executive training program for newly appointed Chiefs. The Law Enforcement Training Board established the Police Chief Executive Training Program under 250 IAC 2-5-1. This course is designed to provide related topics for newly appointed chiefs of city police departments and towns having a metropolitan police department.

New appointed chiefs shall apply for admission to the executive training program within two (2) months of the date that he or she initially takes office and must successfully complete this program within six (6) months of initially taking office. However, if this program is not being offered during that time period, then the police chief must successfully complete the next available executive training program that is offered after initially taking office. In addition, if there are available openings after being filled by persons mandated to attend, then with the Executive Director's approval town marshals, deputy chiefs or other high-level administrative officers may attend this training.

The police executive training program shall include topics in civil liability, use-of-force, firearms, and emergency vehicle operation; along with media relations, policy making, discipline, accounting/administration, labor laws, cultural diversity, and other department and/or administrative programs. Additional training may include topics that would benefit newly appointed chiefs and/or other administrative staff serving in this position. This training will consist of not less than forty (40) hours of instruction, participation, and an evaluation/examination.

ILEA Fee: \$450 Residents/\$300 Commuters.

If a department needs to cancel a student from an ILEA in-service class, it must be done no later than five (5) working days prior to the start of the class. If a student does not show up or cancellation is made any closer to the start of the class, the agency will be responsible for payment in full for this class.
