**ORDINANCE CONCERNING THE TRANSFER OF FUNDS FROM MVH  
ENGINEERING TO MVH STREETS SIGNS FOR THE TOWN OF  
GREENVILLE, INDIANA**

WHEREAS, the Town Council for the Town of Greenville, Indiana has the authority to transfer appropriations between the town's expense accounts for the operation of the Town of Greenville and;

WHEREAS, the Town of Greenville Budget Sheet handed out to the Council Members at the June 11<sup>th</sup>, 2012 meeting indicates a Budgeted Amount of Five Hundred U.S. Dollars {\$ 500.00} for Motor Vehicle Highway Engineering Account No. 201001312 and;

WHEREAS, the need for funds for Streets Signs exist it would be prudent to transfer funds from Motor Vehicle Highway Engineering Account No. 201001312 to Motor Vehicle Highway Street Signs Account No. 201001222;

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF GREENVILLE, INDIANA, AS FOLLOWS:

1. The sum of Five Hundred U.S. Dollars {\$ 500.00} shall be transferred from Motor Vehicle Highway Engineering Account No. 201001312 to Motor Vehicle Highway Streets Signs Account No. 201001222.
2. The Town of Greenville Clerk / Treasurer shall make these entries reflective on the August 2012 Monthly Budget Sheet submitted to the Greenville Town Council at their August 13<sup>th</sup>, 2012 Monthly Meeting.
3. The August Budget Sheet submitted to the Council shall reflect Motor Vehicle Highway Engineering Account No. 201001312 to have a balance of zero {\$0}. Motor Vehicle Highway Streets Signs Account No. 201001222 shall show a balance available of Five Hundred U.S. Dollars {\$ 500.00}.
4. Passage of this Ordinance authorizes the Town of Greenville Clerk / Treasurer to purchase the following. {3} 20 MPH Signs, {2} Children at Play Signs, {2} Stop Signs and {5} Support Posts, all posts and signs to match existing Town of Greenville Street Signs and Posts. Cost to be charged as a credit against Motor Vehicle Highway Streets Signs Account No. 201001222.
