**RESOLUTION CONFIRMING THE RESURFACING AND REPAIR OF  
CLARK STREET FROM PEKIN ROAD TO VOYLES ROAD WITHIN  
THE TOWN OF GREENVILLE, INDIANA**

WHEREAS, the Town Council for the Town of Greenville, Indiana, in the interest of public safety has determined that Clark Street from Pekin Road to Voyles Road within the Corporate limits of the Town of Greenville is in the need of repair and resurfacing and;

WHEREAS, sufficient funds are available in the Motor Vehicle Highway Streets and Alleys Account No. 201001315, Snow Removal and Salt Contractor Account No. 201001361 and Local Roads and Streets, Streets and Alleys by Contract Account No. 202001362 and;

WHEREAS, multiple bids were received at the May 13<sup>th</sup>, 2013 Monthly Meeting to perform asphalt repair and resurfacing and;

WHEREAS, by a vote of 4-0 by the Greenville Town Council selected Libs Paving Co., Inc. bid dated 4-5-13 attached;

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF GREENVILLE, INDIANA, THE FOLLOWING:

1. Awarding of this contract is contiguous upon receiving written confirmation that Libs Paving Bid is based upon invitation for bid from the Town of Greenville dated February 11<sup>th</sup>, 2013 {see letter dated 5-14-13 attached}.
2. Project area shall be from Voyles Road running east to Pekin Road for a total cost not to exceed \$ 28,670.00.
3. The Greenville Clerk Treasurer shall charge the cost of this project as a credit against the following Town of Greenville budgeted accounts.
  - Local Roads and Streets, Streets and Alleys by Contract Acct. No. 202001363 \$ 9,500.00.
  - Motor Vehicle Highway, Streets and Alleys by Acct. No. 201001315 \$ 12,200.00.
  - Motor Vehicle Highway, Snow Removal and Salt/Contractor Acct. No. 201001361 \$ 6,970.00.

1. All bids are to be sealed and be received no later than 4:00 pm April 5<sup>th</sup>, 2013 at Greenville Water Utility on Clark Street, Greenville, IN. Bids are to be given to Amy to put in in-box for Talbotte Richardson, President Greenville Town Board.
2. Weed eat all grass from edges, apply tack, wedge and level low areas, mill at each end of street , feather in by two feet all driveways and adjoining streets, kill all grassy areas within existing asphalt. Out to out means edge of existing roadway to edge of existing roadway.
3. All bids are to have a work schedule for start and completion for each section so we may notify public for street closures.
5. All project areas are to be clearly marked by contractor.
6. Contractor is to set up road blocks before start of asphalt work and remove road blocks once asphalt is cured and ready for traffic.
7. Upon completion of project, itemized invoices are to be submitted to Town Clerk through Amy at Greenville Water Utility for submittal to Town Council for approval of invoice payment.
8. Selected contractor is to provide current certificate of liability and workman comp. insurance prior to construction.
9. All asphalt resurfacing and to conform to state, county specifications.

11. Clark Street to have applied 1 ½" surface out to out.
12. Project area {Clark Street} shall be from Pekin Road running west through the west side of Cross Street and from Voyles Road running east to the west side of Cross Street.
13. Item one on bid shall be Pekin Road running west through the west side of Cross Street.
14. Item two on bid shall be Voyles Road running east to west side of Cross Street.
15. All bids shall be in compliance with this Invitation to Bid and attached to your bid submittal.
