ORDINANCE NO. 2010-M-030

**ORDINANCE CONCERNING THE REGULATING OF PARKING ON
PUBLIC OWNED SIDEWALKS AND CURBS WITHIN THE TOWN OF
GREENVILLE, INDIANA**

WHEREAS, the Town Council for the Town of Greenville, Indiana, in the interest of public owned sidewalks and curbs, has deemed it necessary that the Town develop a Traffic Ordinance which forbids operating a motorized vehicle of any type, idling at a stop, or parking upon any sidewalks within the Corporate limits of the Town of Greenville;

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF GREENVILLE, INDIANA, AS FOLLOWS:

1. It shall be deemed a traffic violation by the Town of Greenville Council and enforceable by the Greenville Marshal Department to operate a motorized vehicle of any type, idling at a stop, or parking upon any sidewalks or curbs within the Corporate limits of the Town of Greenville.
2. It shall be deemed a traffic violation by the Town of Greenville Council and enforceable by the Greenville Marshal Department to repair or clean any type of vehicle upon any sidewalks within the Corporate limits of the Town of Greenville.
3. A traffic citation fine of Fifty U.S. Dollars {\$50.00} shall be issued by the Greenville Marshal Department for any individual in violation of this Ordinance.
4. Exemptions from this Ordinance;
 - Lawn tractor equipment and lawn mowers.
 - When being directed to do so by a Greenville Marshal or Auxiliary Department Member in the case of an accident or natural disaster.
5. This Ordinance shall be effective upon its passage by the Greenville Town Council and publication in the New Albany Tribune of New Albany, Indiana.
6. The Town of Greenville Clerk Treasurer shall publish this Ordinance within 30 days in the New Albany Tribune after passage.
