

**TOWN OF GREENVILLE
ORDINANCE NO 2010-M-041**

**AN ORDINANCE ESTABLISHING FEES FOR
ACCIDENT AND/OR INCIDENT REPORTS**

Whereas, the Greenville Town Council, Greenville, Floyd County, Indiana, deems it necessary to impose a fee for filing and processing Accident and/or Incident Reports.

Now therefore, be it ordained by the Town of Greenville Council, that from this date and hereafter of passage and adoption of this Ordinance, the Greenville Marshal Department is authorized and directed to collect a fee of Eight Dollars (\$8.00) for each Accident and/or Incident Report made by the Department.

BE IT FURTHER ORDAINED, that a receipt be issued by the Greenville Marshal Department for each report charged and collected: that the revenues collected shall be delivered to the Town of Greenville Clerk Treasurer and such revenues authorized by this Ordinance shall be deposited in a fund for the purpose of maintenance, equipment and/or training for the Greenville Marshal Department.


This Ordinance shall be effective upon its passage by the Greenville Town Council and publication in the New Albany Tribune of New Albany, Indiana.

The Town of Greenville Clerk Treasurer shall publish this Ordinance within 30 days in the New Albany Tribune after passage.



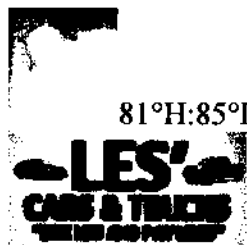
