**ORDINANCE CONCERNING PROVIDING A LIFE INSURANCE POLICY FOR THE
EMPLOYEES OF THE GREENVILLE WATER UTILITY OF THE TOWN OF
GREENVILLE, INDIANA**

WHEREAS, the Water Utility Council for the Town of Greenville, Indiana, is desirous to provide New Term Life Insurance Policy for the Employees of the Greenville Water Utility of the Town of Greenville;

NOW, THEREFORE, BE IT ORDAINED BY THE WATER UTILITY COUNCIL OF THE TOWN OF GREENVILLE, INDIANA, AS FOLLOWS:

1. The Greenville Town Clerk shall purchase Term Life Insurance Policies from:

2. The following Greenville Water Utility Employees shall have the following Term Life Insurance Policies provided as quoted by Agent Chuck Winn of Farm Bureau Insurance on May 25th, 2010 through e-mail.

Gary Getrost, Water Utility Superintendent - \$100,000 policy, Cost \$805.00 per year.

Amy Stone, Water Utility Office Manager - \$50,000 policy, Cost \$222.50 per year.

Steven Schmitt, Water Utility Asst. Superintendent - \$50,000, Cost \$115.00 per year.

Crystal Burkhart, Water Utility Clerk - \$50,000 policy, Cost \$114.00 per year.

These Life Insurance Policies shall be purchased no later than July 1st, 2010.

All current Term or Whole life Insurance Policies shall be allowed to expire at renewal date. Any employee wishing to continue these policies may do so at their own expense.
