**ORDINANCE CONCERNING THE VACATING OF AN UNIMPROVED  
PUBLIC WAY WITHIN THE TOWN OF GREENVILLE, INDIANA  
CORPORATE LIMITS**

WHEREAS, the Town Council for the Town of Greenville, Indiana has received a request from Nathan Stock owner of Lots 25 and 26 as shown on Floyd County, Indiana Plate No. 134 Greenville, Indiana to vacate an Unimproved Public Way adjoining his property. See attached list of adjoining properties.

WHEREAS, the Town Council for the Town of Greenville, Indiana is granted the authority to vacate a Public Way by I.C. 36-7-3-12 and;

WHEREAS, the Town Council for the Town of Greenville, Indiana Published notification in the New Albany Tribune on June 14<sup>th</sup>, 2014 and held a Public Hearing on July 14<sup>th</sup>, 2014 at 6:30 PM at the Greenville Town Hall and;

WHEREAS, the Unimproved Public Way to be vacated are more particularly described as the alley way between Lots 31 and 46 on Floyd County, Indiana Plate No. 134 running to the East boundary of Lots 51 and 52 on Floyd County, Indiana Plate No. 134.

**DESCRIPTION OF PUBLIC WAY**

A sixteen foot wide public way as shown on Floyd County, Indiana Plat No. 134 of Greenville, Indiana, said sixteen foot wide Public Way being the Public Way between Lots 31 and 46, and running East ending at Lots 51 and 52. The public way will be equally divided between owners of adjoining properties.

WHEREAS, the Unimproved Public Way to be vacated shall be subject to any and all easements and/or restrictions of public record that may apply to the Vacated Public Way and to the Real Estate contiguous to them and;

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF GREENVILLE, INDIANA, AS FOLLOWS:

SHALL BE VACATED.

1. A sixteen foot wide public way being the public way running between Lots 31 and 46 on Floyd County, Indiana Plate No. 134 running to the East boundary of Lots 51 and 52 on Floyd County, Indiana Plate No. 134.
2. This Ordinance shall be in full force and effect from and after its approval by The Greenville Town Council of Greenville, Indiana and publishing within 30 days in the New Albany Tribune.
3. Mr Stock has given check number 147 for one hundred dollars (\$100) to the Town of Greenville for all notifications and publishing cost incurred for the vacating of this public way. Any remaining dollars shall be refunded to Mr Stock. Likewise, any overages will be said by Mr. Stock
4. The Greenville Town Clerk shall provide a copy of this signed Ordinance upon its approval to the Floyd County Recorder, Floyd County Auditor.
